This are the only Hart High School District Schools where we are permitted to practice. Please do not attempt to practice at any of the other schools.

## NO PETS ARE ALLOWED ON ANY SCHOOL PROPERTY

Saugus Union School District Elementary Schools may be used for practice but each coach must schedule their times with each school. There may be a fee charged. Region 46 will not be responsible for those fees.

Bridgeport Park, Heritage Park, Santa Clarita Park, Chesebrough Park, Pacific Crest and Bouquet Canyon Park are Cityowned and are permit-only parks rented to other entities. West Creek Park is a county owned park and is a permit-only park too. We may not practice at these parks if they have been permitted.

Northbridge Park is City owned and available on a first-come, first-serve basis.

## City of Santa Clarita Recreational Facility Parking

The fall season at Central Park is a busy time of year. Our youth participants enjoy various athletic pursuits on the fields. Safety is our top priority, which includes compliance of all parking rules and regulations. In an effort to ensure safety, please adhere to the following:

- Parking is allowed in designated parking stalls only and along Bouquet Canyon Road, where identified.
- It is illegal to park in red painted areas.
- It is illegal to double park.
- It is illegal to drive over and park on curbs, mulch, or grass.
- It is illegal to park in front of driveways and walkways.

We encourage you to PARK and drop off participating athletes by their designated fields, carpool, and allow extra arrival time. All of these options will help ease the parking problems at both parks and ensure safety. Parking lots will be monitored, rules enforced, and citations issued. Additionally, always drive slowly through our parks.
